ACCORDING INFO RECEIVED HERE FROM AMCOAX-ONE, MEETING WAS HELD IN HAVA 7 JUL BY MRR, MRP, 30 NOV, RESCATE, DR, MDC AND UR FOR PURPOSE UNIFYING UNDERGROUND AT WHICH IT WAS DECIDED MENDOZA WOULD BE SEET MIAMI AS EXTERNAL CO-ORDINATOR MRP. DISPATCH FOLLOWS. WHILE WE HAVE NO KNOWLEDGE KUBARK PROPOSITION AS ALLEGED, IT IS CONCEIVABLE MENDOZA CONSIDERED AMCOAX-ONE OR AMPU-JES AS REPRESENTING KUBARK.

2. CONCUR SUSPENSION CONTACT AMBANG-FOUR.

WH COMMENT: \*Concerned changes reported Miami press by Manolo RAY and external MRP committee of KUBARK meddling internal affairs of MRP with intent to divide and destroy. \*\*Said in view developments, if Hqs concurred WAVE would suspend contact with AMBANG-4, who member MRP external committee and one of signers published protests.
