1. Reference is made to your letter dated 12 July 1962, entitled as above, to our 100-3/173,735, dated 25 September 1962, and to your file number 105-93295.

2. Information from [redacted] indicates that one Joseph KUMAI, born 10 May 1921, Landerion, Utah, possibly a Soviet citizen, living at Le Laine, France, and a Russian refugee, was listed by the French Ministry of Interior as potentially dangerous during the visit of Nikita Khrushchev to France from 15-20 March 1960. Approximately two thousand other individuals were also listed.

3. [redacted] reported on 9 November 1962, that Josef KUMAI (sic) had not attracted their attention. [redacted] advised that this is tantamount to a "no trace" reply.

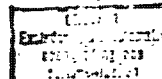

1. Attached for your information is an FBI report on an interview with Andrij DIDKOWSKYJ, contact of Semen POBORILIJ and correspondent of Antin HUKYPCRAUK.

2. The FBI has requested any information available in our files or through KLIBARK sources concerning KOZAK's current activities and contacts with the Soviets. The information on KOZAK in the last paragraph on page 3 and the top of page 4 of the attachment, is the latest information we have on KOZAK. This same information was received from [redacted] in [redacted] of 7 December 1960 and gave KOZAK's address as 26 rue Gaston Jaillon, Vesines Chalette, Loiret.

3. [redacted] We would appreciate any information available on KOZAK's current activities and contacts. [redacted]

4. To Vienna: The interview with DIDKOWSKYJ contains a statement that KOZAK left the camp in Salzburg for France with HUKYPCRAUK in 1948 or 1949. Other information indicates that KOZAK came to France in 1946 from Munich. We would appreciate your checking Station and [redacted] files for any information on KOZAK, including biographic data and the date of his departure for France (or Munich). 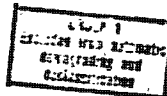

Dr. Gregor KRIVENKO (Arzt, 3.12.1900 in Kiew UdSSR geb., seit 1955 durch Einbürgerung Österr. StA., Wroclawmünster00, Oberösterr., wh.) war seinerzeit in der Ukraine als Arzt tätig und kam im Jahre 1943 mit seiner Gattin Maria geb. Kurotschina und seinen beiden Kindern als Flüchtling nach Österreich. Von 1943 bis 1945 war er als Arzt im Krankenhaus Ried i. I., später im Allgemeinen Krankenhaus in Linz und dann bis 1952 als Flüchtlingsarzt im ehemaligen Flüchtlingslager Ried i. I. angestellt. Seit 1952 geht er keiner geregelten Arbeit mehr nach. Als Befürsorger übt er noch fallweise stillschweigend geduldet die Heilpraxis aus. Im Übrigen betätigt er sich als Organist und Chordirigent in der griechisch-orthod. Kirche in Salzburg. Seine Gattin, die seinerzeit in der Ukraine angeblich Sängerin war, ist gleichfalls-musikalisch tätig. Der Sohn Dr. KRIVENKOS studiert Sprachen, die Tochter ist kränklich und steht in keinem Arbeitsverhältnis. Ein Bruder Dr. KRIVENKOS ist angeblich noch in der UdSSR als Arzt angestellt.

Dr. KRIVENKO lebt mit seiner Familie in sehr bescheidenen Verhältnissen, ist sehr religiös eingestellt und als Antikommunist bekannt. Die ganze Familie genießt einen guten Ruf.

1. Reference is made to previous correspondence from this office regarding the Subjects and to your file number 105-93295.

2. The files of this Agency contain no identifiable information on Andrij DIDKOWSKYJ of 731 North Seventh Street, Philadelphia, Pennsylvania. We have not checked our sources abroad and will not do so unless this action is specifically requested by you.

3. A sensitive Austrian source provided the following information on Semen Spiridon POHORILYJ on 31 October 1961:

"Semen POHORILYI - born 2 February 1910 in Czernassy/Kiev, married, teacher, Ukrainian citizen, resided at the refugee camp in Siezenheim, Salzburg, from 13 July 1950 to 23 August 1950. Prior to 13 July 1950 he lived at the Hallbrunn refugee camp in Salzburg. According to police records Subject left Salzburg for the United States on 23 August 1950."

4. Additional information from the same sensitive source, in the form of a photographic copy of the official police registration card and a negative of an identification photograph of Subject, both dated 7 November 1947, reveals that

"Semen POHORILYJ - born 2 February 1910 in Przenyol, is a Polish citizen, married, teacher, 178 cm tall, gray eyes, blond hair, oval face, no prominent or identifying features."
