1. SUBSEQUENT 7 ACT INTERVIEW AMGLATTER-1 WITH ODENY, IS RETURNED MIAMI WITH AMGLATTER-6. BOTH MET WITH ODENY AND DISCUSSED RE PROTESTANT PEAKS JEWISH OFFICE.

2. WHILE IN MIAMI BOTH AGENTS DISCUSSED CASE WITH ODENY INFORMANT PROBABLY IDENTICAL WITH UNIDENTIFIED ODENY INFORMANT MENTIONED REF. ON 5 NOV ODENY REPORTS FIRED BY PEREZ JIMENEZ, ADMITTED TO ODENY SEE PLATED LATTER'S OFFICE AS PART KIDNAP PLOT.

3. CLAIMS INFORMED CESAR E. GARCIA COVANI, FORMER JUSTICE MINISTER UNDER BETTADA, THAT WRITING TO RAYO, GARCIA QUESTIONED ABOUT LETTERS. DENIED WRITING RAYO, BUT FIRED PROBABLY BECAUSE GARCIA INFORMED PIECE OF ACCUSATION.
