<p>1. The following was prepared by Paul D. KILBACK.</p> <p>2. The information below was acquired through QUWLB interrogation of CC-3120, Angel AVELLO Herrero, a Cuban refugee and former resident of Havana City who left Cuba on 8 May 1967. Until October 1966, he was employed by the MICOES (Construction Ministry), Havana.</p> <p>a. Ivo *CONDE, secretary of the MICOES labor union, is a <del>MC</del> member and holds the rank of Army lieutenant. He is described as Caucasian, about 5'10" tall, weight about 145 pounds, 30-35 years old, straight black hair.</p> <p>3. The information below was acquired through QUWLB interrogation of CC-2982, Julio Arnaldo HERRANDEZ Arencibia, a Cuban refugee and former resident of Mariacao, who left Cuba on 24 August 1966 on board the Cuban motorship LALAS, on which he was employed as a wiper. He deserted the ship on 19 November 1966 in Santurce, Bilbao, Spain. In 1958, when source was 16 years old, he belonged to the 26th of July movement and was a close friend of 26th of July members, Alberto SANTANA, Omar HERRANDEZ Cruz, and Luis FERRANDEZ. - a. Alberto \*SANTANA, DSE lieutenant, works as an investigator for the DSE. He is described as Caucasian, about 5' tall, weight about 110 pounds, about 30 years old, wavy black hair, afflicted with facial acne, lives at No. 64, Calle Sitios, between Bayo and San Nicolas, Havana, shoe & carpentry shop. He drives a 1957 Chevrolet painted light cream color.
- b. Omar \*HERNANDEZ Cruz, is employed as Auditor Interrogador (Judge Advocate?) by the DSE and acts as public accuser in important trials. He is described as Caucasian, about 5'4" tall, weight 190 pounds, 24 year old, straight brown hair, lives at No. 6 Calle Maloja, between Aguila and Angeles, Havana, drives a 1958 Ford painted white and black.
- c. Luis \*FERNANDEZ, Chief of the DSE investigative group, is described as Caucasian, about 6'1" tall, strongly built, weight about 200 pounds, very low forehead and hairline, large round face, thick lips, small sunken eyes, 24 years old, lives at either No. 205 or No. 255 Calle Florida, between Esperanza and Vives, Havana City, on the top floor. He is married to Mary (lru), has no children. He has three automobiles: a 1959 Plymouth painted white, a bottle green 1957 Pontiac, and a black 1957 Buick. In February or March 1967 he participated in the capture of a group of persons attempting to leave Cuba clandestinely via Playa de Guanabo.
- d. Personnel of the Cuban motorship IMIAS:
  - (1) Captain Oscar M.\*ORUE appears not to be a Communist; he speaks very badly of the Cuban and Soviet systems, and treats the crew very well. He is described as Caucasian, 6' tall, weight about 200 pounds, about 27 years old, straight black hair, wears glasses and, on occasion, contact lenses.
  - (2) \*ARIAS Lezcano (fm), First Mate, is one of the most hated men on board. He is very pro-regime and unhesitatingly denounces crew members. He is described as Caucasian, 5'2" tall, weight about 230 pounds (sic), about 33 years old, wavy blond hair, wears a small beard.
  - (3) Julio \*SARDINAS, Third Mate, recently graduated from the Mariel Academy, is described as a UJC member, Caucasian, 5'5" tall, weight about 130 pounds, about 25 years old, balding but with some blond hair remaining.
