AGGRESSIVE PUBLIC RELATIONS AND INTERNATIONAL BUSINESSMAN REGISTERED AS AGENT FOR NICARAGUA, ISRAEL, INDONESIA, ECUADOR AND HAITI AND CONTACT OF PRES. BALAGUER OF DOM REP. HAS HAD SOME CUBAN EXILE CONTACTS INCLUDING THAT DESCRIBED REF C.

2. FILES SHOW DAVIDSON IMPLYING CONTACT WITH U.S. GOVERNMENT OFFICIALS AT "HIGHEST LEVEL" AS EARLY AS 1957 IN DEALINGS WITH UNSUSPECTING CLIENTS, PARTICULARLY FOREIGNERS, AND HAS HAD NO COMPUNCTIONS ABOUT INDICATING CLOSE CONNECTIONS WITH STATE, FBI AND WHITE HOUSE.
