FOR WAVE: WISE SUGGEST THAT ANTHRILL TRIP NOT BE INITIATED UNTIL RAULITO ROA'S WHEREABOUTS EUROPE ESTABLISHED SINCE IMPORTANT CONTACT ROA AS LATTER INCLINED TALK FREELY ABOUT INTERNAL/EXTERNAL SITUATION CUBA WHEN IN TOUCH WITH TRUSTED FRIENDS OR RELATIVES.
