1. IN EFFORT CLARIFY REPORT WAVE 8242 THAT PEDRO MIRET PRIETO UNDER ARREST, AMCHEER-1 CONTACTED CESAR FAGET, EMPLOYEE PANAM NEWS WHO CLAIMED HE RESPONSIBLE FOR RELEASE. FAGET TOLD AMCHEER-1 THAT HE HAD RECEIVED INFO FROM EXILE LAWYER WHO PERSONALLY KNOWN TO FAGET AND THAT LAWYER HAD IN TURN RECEIVED INFO VIA PHONE CALL WITH PERSON IN HAVA 11 FEB WHO REPORTED MIRET AND SISTER-IN-LAW RAQUEL PEREZ UNDER HOUSE ARREST FOR SEVERAL DAYS. FAGET REFUSED GIVE IDENTITY EITHER LAWYER OR SOURCE IN HAVA.
2. ACCORDING AMOT INFO, RAQUEL PEREZ GONZALEZ IS WIFE LUIS MIRET PRIETO WHO BROTHER PEDRO. LUIS PRESIDNET JUCEI HAVA PROV. BOTH RAQUEL AND PEDRO EARLY MEMBERS 26 OF JULY MOVEMENT AND REPORTEDLY STILL IN GOOD FAVOR REGIME.
3. WAVE HAS RECEIVED NO INFO WHICH WOULD CONFIRM WHAT APPEARS BE HIGHLY QUESTIONABLE PANAM NEWS REPORT.
