A. WOULD USE PSEUDONYM (IDEN) FOR BOOK.

B. WOULD LEAVE FOR MIAMI ON 18 JULY AND WANTS FLY VIA DALLAS, TEXAS. HE WOULD FLY TO DALLAS AND IN DALLAS BUY ROUND TRIP TICKET TO MIAMI AND RETURN TO MEXICO VIA DALLAS.
