This office has been in receipt of info that Pedro DIAZ "Lanz and Frank FIORINI have organized a Cuban Rev. group and purchased 2 former Navy 83 ft. vessels and 2 31 ft. "moppies" which were to be used in an expedition against the present govt. of Cuba. The 2 83 ft. vessels and 1 31 ft. "moppies" were located, docked at Just Island, Miami River, by Customs Port Investigators, and were placed under intermittent surveillance.
On April 17, 1962, vessel was for sale.

LIAISON GROUPS INC. facilitated a letter requesting to see us, from a friend who was a member of a counter-intelligence course under the leadership of such individuals... The group called itself "International" - the return address on the envelope was the address that MR. MCCARTHY, former SD chief, gave them, plus (postscript) "your duty demanded". *is fine*
Very often we're in contact with the anti-Castro group FID. They had some 40 alias from Miami via VINA, Jr., a lawyer. Camp site described as of 30 don type. On 8 Jun 1963 a twelve year old Cuban girl was taken from her home by agents of the CIA, and one of them was later arrested, April 1964. Also recently, a Cuban girl, 15 years old, was taken from her home by agents of the CIA, and she was released. This occurred July 1963. The CIA had a camp which they described as consisting of 3 structures, one into which was an insulation house, where persons come unaccompanied - purchased either to avoid appeal to the public. Some of these were American citizens, some Cuban citizens. Each building contained a number of rooms, some were open, some were closed. One of the buildings had 100,000 ft².
Report to July of 63 stated to headed on information known as the International Anti-Communist Brigade, totaling a membership of 5,000 men. Reliable source said this was much with Cuba the only member, and that it is nothing but a paper organ. Received info via VINA, Jr. 17 Aug 63, 201-32754, *not to circulate*.
