1. PHASE POUCH SOONEST FULL NAME AND CURRENT ADDRESSES FOR PURPOSES OF MAILING AUGUST AND SEPTEMBER CHECKS FOR RETURNED STRIKE FORCE PERSONNEL. PAYMENTS FOR AUGUST AND SEPTEMBER AT RATE \$100 PER FAMILY WILL BE HANDLED BY HQ. PERSONNEL WILL BE ADVISED WITH AUGUST CHECK THAT SEPTEMBER WILL BE LAST PAYMENT AND THAT IF THEY HAVE FINANCIAL NEED BEYOND THAT DATE THEY SHOULD GO TO REFUGEE OFFICE AND REGISTER IMMEDIATELY.
2. FYI RESOLUTION OF PAYMENTS TO DEPENDENTS OF NON-RETURNED SF PERSONNEL UNDER CONSIDERATION. APPEARS PROBABLE SOLUTION LUMP SUM TERMINAL PAYMENT IN AMOUNT YET UNDETERMINED.
3. ADVISE AMTIKI-1 THAT OF TOTAL \$501,000 TRANSFERRED PREVIOUSLY, \$350,000 FOR JULY PAYMENTS TO DEPENDENTS BALANCE FOR JULY SUPPORT AIRBORN.
4. WE REQUESTED APPROVAL \$231,375 FOR BALANCE JULY DEPENDENT PAYMENTS, COMPUTED AS FOLLOWS: \$350,000 PER PARA 3 LESS \$313,700 PER WAVE 6939 LEAVES BALANCE OF \$36,300. TOTAL PAYMENTS FOR RETURNED DEPENDENTS PER AMTIKI-1 SCHEDULES \$267,675 LESS UNUSED BALANCE \$36,300.
