

- 3. It is requested that the Headquarters reviewing action 6 described in Reference C for handling the cases of and be expanded to include all the remaining cases and the conclusions reached concerning the ultimate disposition of these cases.
- 4. FYI. An amount of \$250,000 was originally authorized for the medial phase of the AMBUD Program. Expenditures under this program have reached a level of approximately \$245,000 with bills outstanding at the present time of \$3,250. It is evident that the cases remaining which require medical treatment as outlined above will necessiate the expenditure of sums in excess of this amount.
