1. AMHAM 1 BEGAN WORK FOR WAVE IN AUGUST 63. INITIALLY RECRUITED AS RADIO OPERATOR TRAINEE. LATER PLACED WITH NEWLY FORMED AMOZON TEAM AND SINCE MAY 64 HAS SERVED WITH TEAM AS RADIO OP. INCLUDING SALLY XIV AMHAM 1 MADE 17 TRIPS INTO CUBA. WAS ASSESSED AS HIGHLY SKILLED RADIO OPERATOR AND COURAGEOUS AGENT.

2. FOLL EXCERPTS FROM INITIAL DAMAGE REPORT COVERING PERIOD AUGUST 63 - FEBRUARY 66.

A. AMHAM 1 WAS EXPOSED TO 18 STAFF AND CONTRACT PERSONNEL AFFILIATED WITH WAVE, 4 [ ] INSTRUCTORS IN 63, 1 [ ] INSTRUCTOR (WHO NOW ASSIGNED WAVE) IN 64. AS FAR AS KNOWN, ALL PERSONNEL WERE KNOWN TO HIM ONLY BY FIRST NAME (SOME TRUE SOME FALSE).

B. DURING TRAINING AND OPS HE BECAME ACQUAINTED WITH SOME 21 CUBAN AGENTS OF WAVE AFFILIATED WITH SPECIAL OPS OR TRAINING ELEMENTS. SOME KNOWN ONLY UNDER ALIAS, SOME UNDER TRUE NAME. MOST WERE FELLOW AGENTS ON OPS, FELLOW TRAINEES, OR PRINCIPAL AGENTS FOR AMOZON TEAM.

C. HE AWARE OF NAME OF OPS VESSEL CROWN WHICH USED FOR NUMBER AMOZON TEAM OPS. KNOWS CAPT AND CREW BY SIGHT AND FIRST NAME, PROBABLY KNOWS TRUE IDENTITIES OF SOME. AWARE OF GENERAL LOCATION OF BERTHING SITE AT KEY LARGO AND LOADING SITE AT OCEAN CANAL, BUT POSSIBLY NOT EXACT LOCATION (BECAUSE OPS ACTIVITY AT NIGHT).

D. AWARE OF NAME OF OPS VESSEL JADE WHICH USED FOR NUMBER AMOZON OPS. NOT AWARE OF BERTHING SITE. AWARE OF LOADING SITE AT LOWER MATECUMBE AIRSTRIP. KNOWS CAPT AND CREW BY SIGHT AND FIRST NAME, PROBABLY KNOWS TRUE IDENTITIES OF SOME.

E. AWARE OF NAME OF OPS VESSEL MARLIN (NOW NAMED TRITON). NOT AWARE OF BERTHING SITE. HAS LOADED ABOARD MARLIN AT OCEAN POINT, KEY LARGO, WHICH COULD LEAD HIM BELIEVE MARLIN BERTHED AT SAME SITE AS CROWN. KNOWS CAPT AND CREW OF MARLIN BY SIGHT AND FIRST NAME. PROBABLY KNOWS TRUE IDENTITY OF SOME.

F. AWARE OF FOLLOWING WAVE TRAINING SITES, IN SOME INSTANCES EXACT LOCATION, IN OTHERS GENERAL LOCATION. PARAM TRAINING HOUSE. FLAMINGO MARITIME TRAINING SITE. EVERGLADES FIRING RANGE. PLANTATION KEY SURVIVAL SITE. COMMO TRAINING SITE OCALA.

G. KNOWS FOLL SAFE AREAS: NO. 231, AMOZON TEAM AREA, TERMINATED. NO. 293, TEMPO AMOZON TEAM AREA. NO. 341, BIG PINE

[ ] AND [ ] SINCE BLACK FLIGHTS INVOLVED, BELIEVE  
HE NOT AWARE LOCATION EITHER AREA.

J. AMHAM 1 LCFLUTTER 18 AUG 63. EVALUATION HE NOT ENGAGING  
DECEPTION RE ANY SECURITY QUESTIONS. SECOND LCFLUTTER 9 FEB 66  
IN CONNECTION ACCUSATION INDECENT BEHAVIOR BY SAFE AREA NEIGHBOR.  
LCFLUTTER AND INVESTIGATION INDICATED HE INNOCENT. THIS LCFLUTTER  
CONFINED TO QUESTIONS RE INCIDENT. NO APPARENTLY SIGNIFICANT  
SUSPICIOUS SECURITY INCIDENTS ON RECORD.
