AMLASH/1 WAS BRIEFED ON AMTRUNK/9 ^{STORY} ~~SECRET~~ UPON RETURN PBRUMEN 10 FEBRUARY, AMLASH/1 WILL CHECK WITH AMTRUNK/10 WHO PROBABLY KNOWLEDGEABLE AS HE KNOWS MAJORITY GROUP INVOLVED WITH AMICE/14. IF AMTRUNK/9 ARRESTED, AMLASH/1 WILL WRITE LETTER TO UNSNAFU/9 IN PARIS ABOUT LONG AND TIRING TRIP. IF AMTRUNK/9 IN HIDING AND SAFE, AMLASH/1 WILL WRITE ABOUT PLEASANT RETURN TRIP. AMLASH/1 ALSO REQUESTED SEND SW REPORT. IF AMTRUNK/9 ARRESTED, AMLASH/1 FEELS A/10 CAN BEST ASSESS DEGREE OF CONPROMISE AND ACTION REQUIRED.

A/10 HAD RECEIVED ANY PART OF CACHE. A/10 TOLD HIM FISHERMEN RECOVERED MONEY AND PARTS OF COMMUNICATIONS GEAR BUT THAT MONEY WAS NO GOOD SINCE IT WAS IN A SERIES WHICH OUT OF CIRCULATION. FISHERMEN HAD PROMISED A/10 THEY TRYING RECOVER REMAINDER OF CACHE. AMLASH/1 WAS REQUESTED TO CHECK AND REPORT DETAILS BY SW MESSAGE, SPECIFICALLY ITEMS RECOVERED AND CONDITION COMMUNICATIONS EQUIPMENT. AMLASH/1 WAS REQUESTED TO URGE A/10 TO ESTABLISH RADIO CONTACT IF ALL COMMUNICATIONS EQUIPMENT RECOVERED AND IN WORKING ORDER (AMLASH/1 HAS ALWAYS BEEN AFRAID OF OPERATING RADIO INSIDE PBRUMEN; IN ORDER ATTEMPT PRESSURE AMLASH/1 AND THEREFORE A/10 TO ESTABLISH THE CONTACT, USED PLOY THIS TYPE RAPID COMMUNICATIONS ESSENTIAL IF IT EVER NECESSARY COORDINATE EXFILTRATION FOR A/10 OR ANY OTHER ASSET WHO MAY GET IN TROUBLE).
