DESENSITIZED TYPIC AMLASH WHAFRON AMGABE

1. ON 22 JAN EXILE CUBAN LAWYER ALFREDO PORTELA AKA MOP RESIDING 1300 SW 93 COURT MIAMI HANDED WAVE ASSET AMGABE-1 SPECIAL DELIVERY LETTER DTD 20 JAN PARIS FROM AMLASH-1 TO PORTELA. PORTELA EXPLAINED SINCE KNEW AMGABE-1 ACQUAINTED AMLASH-1 ASSUMED MIGHT BE INTERESTED LETTER. EXPLAINED HAD WRITTEN AMLASH-1 EARLY JAN EXPRESSING INTEREST TALKING AMLASH-1 ON CONFIDENTIAL BASIS, HOPING HE MIGHT BE ABLE GET AMLASH-1 ASSIST PORTELA HELP RELATIVES CUBA AND PERHAPS CARRY LETTERS OR PACKAGES THERE.
