IT IS SUGGESTED THAT THE FBI BE CONTACTED FOR ADDITIONAL INFORMATION. Y

2. DEA HAS INFORMED BKHERALD JUNE 74 THAT MEROLA WAS OF OPERATIONAL INTEREST. THEY REQUESTED TRACES AND STATED HE REPORTEDLY WORKED FOR BKHERALD IN LATE 1950'S. WE REPLIED THAT MR. MEROLA HAD NEVER WORKED FOR BKHERALD, ALTHOUGH WE WERE AWARE THAT HE HAD MADE SUCH CLAIMS ON NUMBER OF PREVIOUS INSTANCES. Y
