- A. SURFACE ANY EVIDENCE CASTRO FINANCING TERRORIST AND PRO CURIA ACTS;
- B. SURFACE ANY PROOF LOCAL TERRORIST AND PRO CURIA GROUPS RECEIVING <sup>MATERIALS,</sup> GUIDANCE AND ORDERS FROM HAVANA BY ANY MEANS.

3. PARA 2 ABOVE ACTION SHOULD BE SLANTED SO AS NOT TO APPEAR AS ISOLATED CASES BUT RATHER AS PART OF HEMISPHERE WIDE PICTURE. IN THIS CONNECTION BELIEVE THAT PREVIOUSLY SURFACED MATERIALS THIS NATURE COULD BE REFOCUSSED AND PUBLICIZED AGAIN IN CURRENT CONTEXT.
