1. HERWITCH STATEMENT UNFORTUNATELY POSSIBLY SUBJECT MISINTERPRETATION BUT HEADQUARTERS FIRM POSITION WITH WHICH ODACID IN AGREEMENT IS AS STATED REF B. MESTRE WAS GIVEN FUNDS FOR SALARIES OF EMPLOYEES WHO PERFORMED VARIETY OF DUTIES INCLUDING ISSUING NEWS BULLETINS AND PREPARING RADIO PROGRAMS. SINCE THIS GROUP ASSOCIATED BY AMEMB HQS EXPECTS SALARIES TO COME FROM BASIC BUDGET. ADDITIONAL FUNDS WILL BE PROVIDED FOR NEW PROJECTS WHEN APPROVED BY HQS.

2. HQS CONSIDERS ESSENTIAL THAT LINE BETWEEN BASIC BUDGET EXPENSES AND NEW OPERATIONS BE CLEAR-CUT AND BE ESTABLISHED BEFORE NEW OPERATIONAL PROJECTS ARE PROPOSED. PARA TWO REF B IS PRACTICAL SUGGESTION FOR ESTABLISHING LINE.
