1. CONFIRMING TELECON 31 OCT HARRISON/TORREY CRITERION FOR FUNDING AMBUD IS PER REF B, THAT IS MONTHLY PAYMENT ~~XXXXXXXXXXXXXXXXXXXX~~ DYPAT DYGUY DYMAX FOR ADMINISTRATIVE EXPENSES, AND PLANS FOR SPECIAL OPERATIONS TO BE SUBMITTED BY AMBUD-1 THROUGH PASSAVOY FOR HQS APPROVAL.

2. FOR THIS PROCEDURE TO OPERATE SATISFACTORILY HQS CONSIDERS ESSENTIAL THAT ALL CONCERNED HAVE CLEAR UNDERSTANDING WHAT EXPENSES ARE PROPERLY CHARGED TO MONTHLY SUBSIDY. HQS GENERAL VIEW IS THAT OFFICE EXPENSES, SALARIES, AND MINOR EXPENDITURES FOR SUPPLIES AND SERVICES SHOULD COME UNDER THIS HEADING. HOWEVER, IN ORDER AVOID ANY FUTURE MISUNDERSTANDINGS, REQUEST DURING NEXT TWO WEEKS HAVE OBTAIN FROM AMBUD-1 DETAILED ACCOULT OF MONTHLY EXPENDITURES, PLUS BRIEF STATEMENT OF ROUTINE DUTIES OF EACH SALARIED EMPLOYEE. AFTER THIS IS RECEIVED THE AMOUNT BUDGETED FOR THESE EXPENSES SHOULD BECOME STABLE AND EXPENSES FOR SPECIAL OPERATIONAL ACTIVITIES WILL BE FUNDED PER PARA ONE ABOVE.
