1. RESTRICTION ON SABOTAGE IN REF A APPLIES ONLY TO EXPLOSIVE AND INCENDIARY TYPE ACTIONS SUCH AS LIMPETS AND SHAPE CHARGES.

2. WISH TO EXPLORE POSSIBILITY OF NON VIOLENT METHODS OF SABOTAGING CUBAN SHIPS OR THEIR CARGOES WITH EACH APPROPRIATE AMLEG AGENT. THEREFORE, REQUEST EACH ASSET ASSESSED AS BEING SUITABLE AND WILLING TO DO SABOTAGE BE ASKED WHAT HE CAN DO TO HIS SHIP TO DELAY ITS SAILING OR TO CAUSE IT TO BREAK DOWN AFTER IT LEAVES A PARTICULAR PORT. (FRAN) HAS AVAILABLE A BIOLOGICAL CONTAMINANT, WHICH CAN BE PUT INTO FUEL SYSTEM OF SHIP AND AN ABRASIVE FOR USE IN LUBRICATING SYSTEM. IDEAS OTHER THAN CONTAMINANTS ON WHAT CAN BE DONE TO SHIP MUST DERIVE FROM DEBRIEFING CREW MEMBERS THEMSELVES WHO ARE ONLY ONES FAMILIAR WITH INTRICACIES OF THEIR OWN SHIP. IN ADDITION TO CONTAMINANTS, ERRORS OF COMMISSION OR OMISSION SHOULD BE EXPLORED - I.E.

3. REQUEST (HAMB) AND (BRUS) VIEWS ON POSSIBILITY OF USING AMLEG/1 OR (NIERGOT) TO CONDUCT BRIEFINGS WITH AMLEG AGENTS ON NON VIOLENT SABOTAGE ACTS. WISH TO MINIMIZE ODYOAE SPONSORSHIP OF SABOTAGE ACTS WHENEVER POSSIBLE.

4. GUIDANCE ON BRIEFING OF CHIEFS OF MISSION PER REF C IS REVISED AS FOLLOWS. THIS PROGRAM IS TO BE HELD ON STRICT NEED TO KNOW BASIS. THEREFORE NO BRIEFING OF ODACID PERSONNEL IS TO TAKE PLACE WITHOUT PRIOR APPROVAL FROM HQS. REQUESTS FOR APPROVAL TO BRIEF WILL, IN MOST CASES, BE DENIED. RATIONALE FOR THIS REVISION IS THAT ODACID FULLY REPRESENTED IN APPROVAL OF THIS PROGRAM AND MAY BRIEF THEIR CHIEFS OF MISSION THROUGH THEIR OWN CHANNELS IF THEY WISH TO DO SO.

5. NO SAB ACTS TO BE ATTEMPTED WITHOUT PRIOR SPECIFIC HEAD APPROVAL.
