Meeting will be 18th in a.m.

Status of "Definition" - with OMB re paperwork act (10 days)
Then Federal Register

Future issues - transfer of collection to ARRB HQ

Purpose of Meeting on 18th -- defend "postponements"

ARRB Staff will characterize postponements in the documents under discussion (grouping deletions into categories); will send of copy of list of categories prior to meeting

Agency -presents reason for postponements in term of JFK Act
-- wording of law re 1A, 1B

Expect specific questions /goal is an exchange of views
Board approach will focus on the wording of the law

Marwell: "choose your battles" - focus on most important issues

ARRB question -- why after 30 years protect:

crypts, names such as John Whitten, Shaw, White
Gunn recommended that we determine status of Mexico City
players (Tarasoffs, Manells); need to be specific on status
of officers, i.e., living overseas, etc.

John asks re chronological issue -- per Marwell has not been
Board's approach

The issue of documents not related to the assassination; per
Marwell the Board weights each postponement vs. public
interest/need to know -- for documents that do not deal with
the assassination, "public interest" may not be as high.

Board issue: information available to the public but not
officially acknowledged --example Agee
John pointed out that Agee is known to have attempted to
elicit confirmation of information he did not have access to
or only suspected. Agency position is not to comment on his
statements.
