3. MEXI SUGGESTING TO LITEMPO 2 THAT SILVIA DURAN WHO MEXICAN EMPLOYEE AT CUBAN EMBASSY AND WHO PUT LEE OSWALD ON TELEPHONE FROM CUBAN EMBASSY TO TALK TO SOVIET EMBASSY ON 28 SEPT BE ARRESTED IMMEDIATELY AND HELD INCOMMUNICADO UNTIL SHE GIVES ALL DETAILS OF OSWALD KNOWN TO HER. (SEE REF B)
