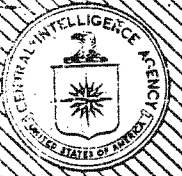

HERNANDEZ REITERATED THE PERSONAL INTEREST OF FIDEL ~~C~~ A S T R O, *Cuba*
PRESIDENT OF THE COUNCILS OF STATE AND MINISTERS, IN THE
DISPOSITION OF THE CASE AGAINST BOSCH. FURTHERMORE, HERNANDEZ
SAID THAT SHOULD THE VENEZUELAN GOVERNMENT DECIDE THAT THERE
IS INSUFFICIENT EVIDENCE AGAINST BOSCH IN CONNECTION WITH THE
CUBANA CASE, THE CUBAN GOVERNMENT WOULD BE INTERESTED IN EXTRA-
DICTING BOSCH. THE CUBAN GOVERNMENT, THE AMBASSADOR SAID, HAS
MORE THAN ENOUGH EVIDENCE TO CONVICT BOSCH OF TERRORIST ACTIVI-
TIES WHICH RESULTED IN THE DEATH OF MANY PEOPLE. (SOURCE
COMMENT: PRESIDENT PEREZ' REACTION TO THE CUBAN REQUEST IS NOT
KNOWN.)
