Referenced Bureau letter to Miami 2/3/64 referred to report of SA GEORGE E. DAVIS, JR., at Miami, 1/15/64, captioned "LEGION BARAGUA", wherein information was reported originating with RENE SIERRA, as furnished to CIA, to the effect that SIERRA participated in two boat trips to Cuba. On the second trip, the mission failed because (FNU) MOLINA took a boat radio and called RAUL CASTRO, informing CASTRO of the proposed mission, when they were about two miles from the Cuban coast.

As Indicated in this report, (FNU) MOLINA has been identified with the subject of this investigation. The Bureau may desire to consolidate its file on (FNU)MOLINA with this case. The file on (FNU) MOLINA in the Miami Office (105-8604) is being consolidated.

This report contains information indicating subject was probably on the missing flight with ALEXANDER IRWIN RORKE, JR. (subject of Bufile 97-4623), and GEOFFREY SULLIVAN, and is dead. It is deemed advisable, however, that further investigation be conducted concerning subject, in an effort to substantiate his demise. In view of subject's probable demise, investigation will be primarily centered around substantiating this, rather than the pro-CASTRO allegations. If it is determined the subject is alive, of course, investigation will then be conducted concerning the pro-CASTRO allegations regarding subject.
