SUBJECT DESTABLISHMENT OF CIA REPRESENTATIVE IN CANADA 6. 6 . R. -8

Reference is made to my memorandum to Mr. Fletcher, dated May 2, 1949, wherein it was noted that CFA contemplated assigning former Bureau Agent Samuel Herman Horton as a CIA representative in Ottawa, Canada Seference memorandum also included the fact that Horton was specifically recommended so that he could "properly handle" and thereby gain an entree into the and related organizations by using as a "stepping stone". It was also memtioned that the Bureau's liaison representative to CIA had ascertained that William K. Harvey, also a former Bureau Agent, and now a minor officail of CIA, had advised his superiors that a made a "peculiar personality," and therefore, it would take a good liaison man to handle him properly.

The Director noted as follows: "1. What is record of Horton while with us? 21 The attached letter is unsatisfactory. I don't like its evasiveness. Please rewrite. H."
