The following information was furnished to the Liaison Agent on December 15, 1960, by Mrs. Jane Roman, Central Intelligence Agency (CIA). (S)(U)

A source of unknown reliability has advised CIA that the Chinese Nationalists are collaborating with anti-Castro elements in an effort to overthrow the present Cuban Government. The same source indicated that the Nationalist government is transmitting funds to unidentified anti-Castro individuals. Both of the subjects, Chinese Nationalists, allegedly are involved in this matter. (S) [Jung] reportedly lives in Havana but is now in Miami, Florida. The other subject lives in Havana but is now in ~~Taiwan~~ TAIWAN conferring with Nationalist officials. (S)

TAIWAN Mrs. Roman stated that CIA is making discreet checks in ~~Taiwan~~ Taiwan in order to determine if there is any truth to any of the foregoing information. She stated that the Bureau will be kept advised of any developments. (S)(U)
