Reference is made to your "Information Report" dated March 26, 1959, your number CS-3/392,904, captioned "Nicaraguan Exile Activity in Cuba" which disclosed that Chester Simpson had arrived in Havana a short time before. (S)(U)

There is enclosed one copy each of the report of Special Agent M. Wesley Swearingen, dated June 26, 1959, at Chicago, Illinois, and subject's photograph.

It is noted that in the enclosed report subject's former wife advised that subject left Chicago in February, 1959, and his destination was not known. It is further noted that the enclosed report contains the full name of the subject and his known aliases.

It is requested that this Bureau be advised of any information contained in your files on the subject regarding his past activities, particularly information indicating he has been engaged in Nicaraguan revolutionary activities. It is also requested that through your established sources in Nicaragua you endeavor to determine the subject's whereabouts and if he has been active in Nicaraguan revolutionary activities and, if so, the nature of subject's activity and where engaged.
