1. DO NOT TURN ALVARADO OVER TO THE MEXICANS. WE HAVE OFFICIALLY ASKED <sup>FBI</sup> ~~ODENVY~~ FOR THEIR POSITION ON THIS MOVE, AND PENDING ~~ODENVY'S~~ ANSWER AND OUR FINAL CONSIDERATION, ALVARADO SHOULD NOT BE SURFACED TO THE MEXICANS OR TURNED OVER TO THEM.

2. ADVISE US IF ~~ODENVY~~ IN MEXI ATTEMPTS TO GET YOU TO ACT ONE WAY OR THE OTHER ON THE QUESTION OF TURNING ALVARADO OVER TO THE MEXICANS.

3. PLS NOTE THE COMPLICATING FACTOR THAT ALVARADO MAY BE A NIC AGENT TOO. ~~MANA~~ PLS ADVISE ITS VIEWS. WE AGREE ~~CERTIYROID~~ SHOULD GO MEXI AND BE REACHABLE AT NIC EMBASSY TO BE AT MEXI DISPOSAL.

4. FOR MEXI: NOTE <sup>FBI</sup> ~~ODENVY~~ MAN LARRY KEENAN NOW IN MEXI WAS SENT ESPECIALLY TO FOLLOW UP LEADS ON ENTIRE ASSASSINATION. PLS COOPERATE WITH HIM FULLY.
