Informant advised that he had recently observed four cables prepared by [MIHALLO STEVOVIC] and forwarded to the Coordination Department, Belgrade, pertaining to information received by [STEVOVIC] from VIS source "CHARLY." (S) Informant described these cables as follows: (S)

A. Cable dated [1/23/64] pertaining to [a meeting] of the Interdepartmental Committee [1/19/64]. Information in this cable pertained to an [agreement] regarding the sale of wheat to [Yugoslavia]. (S)

B. Cable dated [1/23/64]. This cable pertained to an Interdepartmental Committee meeting during which [agreement] was reached to provide Yugoslavia with U.S. surpluses. (S)

C. Cable dated [1/27/64]. Cable containing information regarding [instructions] forwarded by the USDS to the U.S. Embassy, Belgrade, [authorizing and instructing the U.S. Embassy to commence negotiations regarding the sale to Yugoslavia of agricultural surpluses under PL 480.] (S)

D. Cable dated [1/27/64]. This cable contains information pertaining to a meeting between representatives of the various departments, agencies and [White House] interested in an improvement in the PL 480 program. (S)

The [USDS and AID] will forward a [circular letter] to all U.S. diplomatic establishments and AID missions located abroad in countries that receive U.S. [agricultural surpluses]. The diplomatic establishments are to be advised that the U.S. Government, due to its policy regarding (S)
