Your letters of April 12, 1978 requested further information on Lee Harvey Oswald. The Army has now completed its file search. The search revealed that an intelligence dossier on him was destroyed in 1973. A copy of the deletion record is attached. It should be noted that the dates on the tracing index are written in the military style of day, month, year.

Using additional information communicated by your staff to Ms. Judy Miller, the Army has also completed an extensive search for the November 22, 1963 telegram requested in the January 26, 1978 letter. The telegram was not located.
