INFORMATION CONCERNING DOMINICAN REPUBLIC SITUATION CAREFULLY REVIEWED FOR ADDITIONAL LEADS TO IDENTIFY UNSUB MEETING WITH GIANCANA WITH NEGATIVE RESULTS. LAS VEGAS TO FURNISH LIST RECENT LICENSE APPLICANTS APPROVED BY NEVADA A GAMING COMMISSION AS POSSIBILITIES. REVIEW INDICATES \$25,000 WORTH OF SLOT MACHINES OWNED BY LES KRUSE IN LATE 1964 LAST REPORTEDLY LOCATED HISPANOLA HOTEL, SANTO DOMINGO. *adlyt*

INVESTIGATION CHICAGO DISCLOSED CARMEN BASTONE IN CHICAGO THIS DATE.
