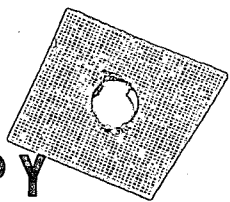

RE NEW YORK RADIOGRAM, MAY 27, 1963.

ON MAY 27, 1963, PCI VICTOR LA CROIX COLLINS WAS INTERVIEWED AND IT WAS STRESSED TO HIM THE FBI HAD NO INVESTIGATION CONCERNING THE MC GUIRE SISTERS BUT WERE INTERESTED IN THE ACTIVITIES OF GIANCANA. (u)

COLLINS STATED HE WOULD BE GLAD TO COOPERATE WITH THE FBI AND KEEP THIS RELATIONSHIP CONFIDENTIAL. (u)

COLLINS ADVISED OF MC GUIRES SCHEDULE AND IT IS THE SAME AS PREVIOUSLY FURNISHED BY JOHN H. TEETER EXCEPT THE ADDITION OF JULY 19 TO 25, THEY WILL APPEAR AT THE CAL-NEVA LODGE, CRYSTAL BAY, NEVADA AND FURTHER, THE MONTICELLO IS IN FRAMINGHAM, MASSACHUSETTS AND NOT FRAMINGTON, MASSACHUSETTS AS PREVIOUSLY STATED. (u)

COLLINS ADVISED GIANCANA HAD NOT BEEN IN NYC SINCE LAST MONDAY, MAY 20, 1963. GIANCANA CAME TO NYC FROM PITTSBURGH WITH THE TROUPE MAY 19, 1963 AND STAYED WITH PHYLLIS MAY 19, 1963 AND LEFT ON MAY 20, 1963. PHYLLIS MC GUIRE JUST HAD HER PHONE NUMBER CHANGED TO PL 2-4481. (u)

COLLINS FURNISHED TELEPHONE NUMBER FO 69709, CHICAGO, ILLINOIS, AS THE NUMBER FOR GIANCANA IN CHICAGO. HE WAS FURNISHED THIS NUMBER BY PHYLLIS AND REQUESTED TO CALL IT ON A NUMBER OF OCCASIONS AND ASK FOR MR. FLOOD. IT IS ANSWERED BY A WOMAN WITH AN ITALIAN ACCENT. (u)

COLLINS ADVISED HE AND THE MC GUIRES ARE GOING TO FRAMINGHAM, MASSACHUSETTS ON JUNE 12, 1963 BUT HAVE NOT DECIDED ON METHOD OF TRAVEL AS YET. (u)

COLLINS WILL ADVISE NYO IF HE HEARS ANYTHING FURTHER CONCERNING GIANCANA. (u)
