DARIUS WASHINGTON JOHNSON, PCI, on 5/21/62, advised that JULIUS KAPLAN, "front man" for ANTHONY RICCI (Miami File 92-112) and associated with RICCI and FRANK DIOGUARDI (Miami File 92-405), in the operation of the Casa Maria Restaurant and Lounge, Dade County, Fla., made inquiry as to whether he and his wife would be interested in staying at the Lido Beach Motel, 17301 Collins Avenue, since there is an indication the motel is to be sold. JOHNSON and his wife operate the lounge at this motel. He stated KAPLAN expressed interest in the lounge and motel.

games at the Patio Bridge Club, Miami Beach, Florida, the past winter season is almost broke and in view of the decrease in activities at Miami Beach, FRIEDLANDER secured a job as pit boss at the Golden Nugget Hotel and Gambling Casino, Las Vegas, Nevada, for \$50.00 a day. He said FRIEDLANDER left Miami Beach for Las Vegas on 5/15 or 16/62.

This source also advised that SAM SCHWARTZ, owner of Wolfie's Restaurant, Lincoln and Alton Roads, Miami Beach, is going to retire and is in the process of selling the restaurant to JERRY BROOKS and CHARLES TOURINE (Miami File 92-106). He said he was told TOURINE's name may be kept in the background and that BROOKS may act as the "front" for TOURINE. He advised the papers have not been signed so far, as they are attempting to "iron out" some minor details which came up.

In addition, he advised that ROBERT GOLDBERG, aka Bob Russell (Miami File 165-23) an employee of AL MONES (Miami File 92-386) left the Miami area for the Boston area, where he will allegedly operate as a bookmaker at the Narragansett Race Track.
