CG SEVEN ZERO FOUR SIX- PC ADVISED SEPT FIFTEEN LAST HE RECENTLY OVERHEARD CONVERSATION INDICATING GIANCANA WAS IN CHICAGO DURING PAST TWO WEEKS ~~PLAYING~~ <sup>PLAYING</sup> CARDS WITH WILLIAM "WILLIE POTATOES" DADDANO AND TWO OTHERS. PC IS CLOSELY ~~ASSOCIATED WITH~~ <sup>POTENTIAL CRIMINAL INFORMANT</sup> FREQUENTLY DADDANO AND KNOWS DADDANO ~~CHICAGO~~ PLAYS CARDS AT MELROSE PARK, ILL RESIDENCE OF PASQUALE "BUCK" CLEMENTI, A GAMBLER AND JUICE COLLECTOR FOR DADDANO GROUP. PC ATTEMPTING TO DETERMINE LOCATION OF THIS GAME. (U)

DOMINIC "BUTCH" BLASI, BODYGUARD OF GIANCANA CONTACTED SEPT FIFTEEN LAST AND INTERVIEWED AT LENGTH; HOWEVER, DECLINED TO INDICATE GIANCANA'S PRESENT WHEREABOUTS. STATED FBI MUST BE AWARE FROM INVESTIGATION ~~OF~~ <sup>OF</sup> BLASI THAT BLASI HAS NOT BEEN WITH GIANCANA SINCE RELEASE FROM JAIL MAY THIRTY ONE LAST. (U)

MC GUIRE AT THIS TIME. STATED GIANCANA FREQUENTLY KEPT MC GUIRE AT BLASI'S RESIDENCE WHEN THEY WERE INTIMATE BUT "AS YOU GUYS KNOW" MC GUIRE HAS NOT BEEN AT BLASI'S SINCE GIANCANA WENT TO JAIL. (U)

BLASI ADVISED HE FELT CERTAIN WHEN AGENTS CONTACTED HIM SEPT FIFTEEN HE WAS TO BE SERVED WITH SUBPOENA TO REAPPEAR BEFORE FGJ SINCE ALL MEMBERS CHICAGO GROUP "ARE WAITING FOR THE OTHER <sup>SHOE</sup> ~~SHE~~ TO DROP." (U)

ALTHOUGH BLASI ADVISED HE WILL NEVER DISCUSS ACTIVITIES OF HIS ASSOCIATES, HE AGREED TO ARRANGEMENTS FOR FURTHER CONTACTS AT OFFICE ON WEST SIDE CHICAGO AT DESIRE OF AGENTS TO DISCUSS "ME <sup>AND ME ALONE"</sup> ~~AND ME ALONE~~. BLASI BEING DESIGNATED PC (Potential Informant) UNDER TEGIP FOR FURTHER DEVELOPMENT. (U)
