Re Tampa airtel to Bureau, 5/10/62.

JOHN JOSEPH VITALE, racket figure from St. Louis, Mo., accompanied by SAM ROTH of St. Louis, arrived Tampa International Airport the a.m. of 5/8/62 and subsequently registered at Hawaiian Village, Tampa.

St. Louis source indicated VITALE to look into tomato business in conjunction with produce business he had in St. Louis.

Tampa conducted fisur VITALE and ROTH, 5/8/62 to 4:55 p.m., 5/11/62, when they both left Tampa International Airport for St. Louis. Fisur not observed in contact with subject, but was observed in contact with FRANK and ANTONIO DIECIDUE, both of whom are past associates of subject.

Subject was not reported in Tampa until afternoon of . Saturday, May 12, 1962, when he was reported at the Columbia Restaurant by PCI DOMINICK LA ROCCA (protect). CASIMIRIO HERNANDEZ, owner of Columbia Restaurant, telephonically contacted, advised Buagents subject and JAMES C. LONGO had just left Columbia Restaurant. Other than above, subject has not been reported in Tampa by informants, sources or neighbors.
