Cleveland Office has advised that numerous attempts to contact CARMEN MILANO have been unsuccessful and that it appeared unlikely that any interview of MILANO relative to the activities of TRAFFICANTE would be productive, and that unless advised to the contrary, MILANO was not being interviewed. Tampa, however, requested that additional efforts to interview MILANO be afforded.

On June 1, 1967, Sgt. JACK DE LA LLANO, Intelligence Unit, Tampa Police Department, advised that he had received information from the Dade County Intelligence Unit to the effect that the following additional telephone numbers have been identified as being contained in the personal papers of TRAFFICANTE, but was unable to state the discumstances surrounding the obtaining of these numbers, including the date obtained or the location where the telephone numbers had been located:
