GUS ALEX, AKA, AR. DAILY SUMMARY.

SHELLY GIBSON WAS FORMER STRIP DANCER AT CABANA CLUB PRIOR TO ITS CLOSING RECENTLY BECAUSE OF REVOCATION OF LICENSE AS RESULT OF RAID BY CHICAGO POLICE DEPT. AT WHICH TIME GIBSON AND OTHER GIRLS WERE ARRESTED FOR SOLICITING DRINKS AND PERFORMING LEWD ACTS.

GIBSON INTERVIEWED AND ADVISED THAT SHE IS ACQUAINTED WITH ALEX AS HAVING DATED A FORMER GIRLFRIEND OF HERS. SHE CLAIMS SHE KNEW NOTHING OF HIS CURRENT ACTIVITIES OR SOURCE OF INCOME. SHE ADVISED, HOWEVER, THAT SHE HAD HEARD THAT ONE THIRD OF THE PROFITS FROM THE CABANA CLUB WENT TO THE OUTFIT. SHE CLAIMED THAT THE CLUB WAS RUN BY JOHN AND GEORGE SPUDEAS AND MIKE ELLIS. SHE ALSO ADVISED THAT THE SPUDEAS BROTHERS HAVE A FINANCIAL INTEREST IN THE CHEZ PARISIAN SHOW LOUNGE, CROSSROADS RESTAURANT AND THE CLUB ROUGE.
