ReBulet to Legat, Mexico, dated 8/17/61, with cc to NY and also Bulet to NY dated 7/10/61, and NYlet to Bureau dated 6/30/61.

PCI HARRY M. HANSEN advised on 9/18/61, that he had no further identifying information on FNU DIAZ and that he had not heard from ALBERT EMKE for several months. He did not know anyone by the name of KENNETH GRAYSON PAXTON, nor had he ever heard this name come up in reference to the prospective oil deals with EMKE.

The NYO indices are negative in regard to PAXTON. Records of the Credit Bureau of Greater NY as furnished by PAULINE DE FIORE to IC JOHN F. GOOD on 8/13/61, and BCI, NYCPD, caused to be checked by SA DAVID G. JENKINS, 8/25/61, were negative re PAXTON.

A pretext telephone call to Attorney JAMES J. CALLY, 150 Broadway, NYC, WO 4-5781, by SA MICHAEL D. MC NAMARA, 9/18/61, under the guise of the caller being a personal friend of DIAZ calling a telephone number which was left with him by DIAZ as a number at which DIAZ could be contacted, elicited no information which would identify or locate DIAZ.

It is to be noted that CALLY appeared as defense counsel in the deportation hearing of THOMAS ALOYSIUS MARINO, AR, NY file 92-669, Bufile 92-2858, carried as a Top Hoodlum in the NYC area.
