CARLOS MARCELLO  
ANTI-RACKETEERING

On 10/22/61, PCI JOSEPH HEGEMAN called SA VINCENT K. ANTLE from New Orleans and said he had met CARLOS MARCELLO in Baton Rouge, La., at latter's request. PCI said he did not know MARCELLO personally before this meeting. PCI said MARCELLO was in Real Estate and wanted to meet PCI because he had heard PCI was in a successful gas and oil enterprise and had good business connections. PCI said he felt from talking with MARCELLO that latter might be influenced to give some pertinent information concerning his involvements. PCI said if desired, he could invite MARCELLO to his Fort Lauderdale, Fla., home and try to convince him it would be to his best interest to meet with FBI representatives and tell them the truth. PCI said he would not return to Fort Lauderdale for at least 10 days.

On 10/27/61, PCI called SA ANTLE from New York and said MARCELLO was coming to New York 10/28/61, and that he would probably see him. PCI said he expected to be in Fort Lauderdale about November 1, and that he would report all pertinent data regarding MARCELLO that he had learned.

Miami did not and UACB will not initiate a meeting with MARCELLO at Fort Lauderdale home of PCI since Miami does not know what data MARCELLO has furnished to the New Orleans Office and because it does not know the ramifications of the present court proceedings against MARCELLO.
