BRADY aka AR," OO Chicago, except that BRADY checked out 5:00 a.m. 1/6/63 and destination unknown but in possession 1963 Buick convertible bearing 1963 Florida license 3-68539.

Fisur conducted 1/9/63 JOE R. DIEZ, Tampa, film clips obtained and DIEZ not in contact with subject.

New York letter to Tampa, 12/31/62 (IO), copy furnished to Miami, set out that on 11/28/62 PCI BOBBY EDWARDS advised SA DONALD E. JONES that he sees JOE ROGERS, true name JOSEPH STASSI, on a daily basis when ROGERS is in town. He stated he was with ROGERS last week at the Stage Delicatessen, 54th St. and 7th Avenue, and ROGERS introduced him to SANTO TRAFFICANTE. EDWARDS stated that TRAFFICANTE was with three other men, and he got the impression from ROGERS that TRAFFICANTE is a "very big man" in gambling in Fla.
