In referenced airtel Milwaukee set forth the results of check of the telephone company for the telephone of PCI Frank Russell. One of the contacts according to these records was a Washington, D. C., telephone number RE 7-9775 on 4/2/62.

In handling the leads set forth in referenced airtel Washington Field should insure a check is made with respect to the identity of the person at the above listed telephone number in Washington. Thereafter, if determined advisable, appropriate investigation should be conducted.

NOTE: Russell, a PCI of the Milwaukee Office, has furnished information concerning the Marcello case and claims to be in contact with Jim Donohue, a Washington lobbyist. Russell claims Donohue has approached him to make contacts with high Government officials in an effort to assist Marcello in litigations. The information furnished by Russell is highly questionable and as a result, Milwaukee, New Orleans and Washington Field are attempting to verify Russell's story by conducting discreet inquiries and checks concerning Russell's past contacts. In referenced airtel Milwaukee set forth the results of telephonic contacts by Russell in Washington, D. C., including the telephone number listed above, but did not set forth a lead for Washington Field to check further in this matter.
