The source contained in this letterhead memorandum is NICHOLAS GRAZIANO, a source of information of the Cleveland Division, whose identity is concealed at his request.

The letterhead memorandum is classified Confidential inasmuch as the information furnished by GRAZIANO could reasonably result in the disclosure of this source of continuing value and jeopardize his future effectiveness.

The information contained in the letterhead memorandum is taken from a copy of a letter from the subject to his parents, which letter was furnished by the subject's father, Mr. C. E. WEBSTER, to Mr. H. JAMES RAND, III, by cover letter dated June 7, 1960. Autostatic copies of both of these documents were provided by GRAZIANO to the Cleveland Office and have been made a part of the Sub A section of subject's file.

In Mr. C. E. WEBSTER's letter, he stated that the letters of invitation are in the process of being properly notarized at Harrisburg, Pennsylvania, and stated that as soon as he received the subject's birth certificate, he will send his sponsors for him to the Immigration and Naturalization Service, which he felt would come about that week.

No further investigation is being conducted at cleveland in this case and this case is being carried in a closed status. The Bureau will be kept advised of any further developments.
