Re Cleveland letter and letterhead memorandum dated 11/29/60.

On December 6, 1960, Mr. H. J. RAND, (Protect - requested) provided an autostatic copy of a letter dated November 28, 1960, from the Embassy of the U.S.S.R. in Washington, D.C., under the signature of N. REZNICHENKO, Chief, Consular Division, addressed to himself, which is as follows:

"Dear Sir,

"I have been asked to advise you that your request concerning Mr. R. WEBSTER's departure from the USSR has been forwarded to the appropriate Soviet authorities for their consideration.

"Upon receiving a reply from them we will be glad to inform you about it.

No further investigation being conducted at Cleveland. The Bureau and other interested offices will be kept advised expeditiously of any pertinent information concerning the subject (as it is received from RAND.)

The letterhead memorandum is classified "Confidential" since the information furnished by the confidential source could reasonably result in his identification and jeopardize the future effectiveness of this source of continuing value.

No further investigation is being conducted at Cleveland, and the Bureau will be kept advised of further developments in this case as they are made available to the Cleveland Division through sources at Rand Development Corporation.
