PCI DORIS C. MC DONALD ADVISED TWENTYONE LAST SHE RECENTLY VISITED FORMER BOLITA KING HOWARD PINDER AT PENITENTIARY JACKSONVILLE, FLA. PINDER SAID TILLMAN STALLINGS, AKA FOOTS INTRODUCED PINDER TO A MAN CALLED SANTOS WHO WAS DESCRIBED AS HEAD OF MAFIA IN MIAMI.
