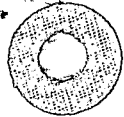

On July 25, 1963, MM T-1, a Cuban exile who was formerly a member of the Cuban Rebel Army and who has contacts with anti-Castro groups in Miami and who has not been contacted sufficiently to determine his reliability, advised that Manuel Aguilar, Chief of FRAC, had been in contact with several people in connection with his plans to go to Cuba. (u)

On July 24, 1963, Aguilar met with Raul Fernandez (or Hernandez), 127 Northwest 13th Avenue, Miami, who knows a man who has 300 pounds of C-3 explosive which he will sell for \$4.00 a pound. This man also has a 57 mm recoilless rifle. Raul Fernandez (or Hernandez) is to see this man in a day or two regarding purchase of this material. (u)

Aguilar also stated that one Raul Ros, who owns a small market at Southwest 8th Street and 35th or 36th Avenue, Miami, has some C-3 which he will sell for \$3.50 per pound. Aguilar was critical of Ros because Ros, as a Cuban would not donate the C-3 to the Cuban cause, but insists upon selling it. (u)

MM T-1 stated that Aguilar had also been in contact with Edward Collins, 220 Southwest 8th Avenue, Miami, an American adventurer who wants to go to Cuba with Aguilar. On July 24, 1963, Aguilar met with Collins and one Dennis Herbert (phonetic) an American in his mid 40's who speaks fluent Spanish. Dennis is bald and is called "Professor." He was with Collins several

weeks ago aboard a boat which was making radio transmissions to Cuba. According to MM T-1, the United States Customs Agent at Marathon, Cesar Diosdado, caught them, but they now have their boat again, docked somewhere on the Miami River. This boat belongs to Dennis, Collins and two others and will be used by Aguilar to transport some people to the island off the Florida Keys prior to making the trip to Cuba. (X)(U)

MM T-1 said that Tom ~~Duncan~~, an American photographer, <sup>FLA</sup> would go on this trip to take film, if possible, of militiamen and anti-Castro fighters in Cuba. Upon returning, these films will be shown to John Birch Society members who are then expected to contribute money and medicine to the cause. Thereafter, Aguilar expects to make a second trip to Cuba, infiltrate with a small group of men, not return to the United States, but stay in Cuba and fight. Aguilar indicated he expected to make the first trip in about a week's time. (X)(U)

<sup>DEWIS</sup>  
Regarding the name Daniel Herbert, [MM T-2, American citizen who has been involved in revolutionary activities in the Miami area for over five years and who has furnished reliable information in the past, advised in January, 1963] that <sup>DEWIS</sup> Daniel Harber (not Herbert) is a homosexual who has been loosely connected with the American adventurers in the Miami area who are engaged in anti-Castro activities. (U)
