On 9/13/63, DL 185-C-TE (DL 137-1387) telephonically furnished the following information:

DAVIS, along with a couple of associates unknown to informant other than by the names of JAMES POLLARD and JIMMY TREMBLE, have set up a bookmaking operation in an apartment in North Dallas where they have telephones TAylor 3-8005 and TAylor 3-7516. (Check ascertained these phones are located in Apartment 210, 1001 Grigsby Street, Dallas.)

The above information was immediately furnished to Lt. JACK REVILL on 9/13/63 and on 9/16/63, Lt. REVILL advised he had just ascertained that the telephones had been moved out of the apartment on the same date, 9/16/63. Lt. REVILL stated he would make efforts to ascertain their new location and the Dallas Office will also attempt to obtain same through informant. Lt. REVILL further advised DAVIS has recently been observed driving a 1963 Buick Wildcat, Texas license MZ 4462.
