REFERENCED CARTEL REPORTED THE LAST CONTACT OF RICARDO MORALES NAVARRETE WITH THE LEGAT OFFICE IN CARACAS ON NOVEMBER 4, 1976. IT INDICATES THAT MORALES CONTINUED TO BE FRIENDLY TOWARD AND WAS STILL COOPERATIVE WITH THE LEGAT OFFICE, ALTHOUGH LEGAT HAD NOT INITIATED ANY UNNECESSARY CONTACTS WITH MORALES IN THE PREVIOUS FEW WEEKS. *(S)u*

IT IS DIFFICULT TO EXPLAIN SOME OF THE COMMENTS ATTRIBUTED TO MORALES RECENTLY, PARTICULARLY HIS REPORTED EXPRESSIONS OF HOSTILITY TOWARD CIA AND FBI. LEGAT HAS HAD NO OPPORTUNITY TO BROACH THE MATTER WITH MOARLES. *(S)u*
