Re Bureau letter dated 9-24-63 requesting background of ANGELO PROVINZANO, which was incorrectly spelled PROVENZANO in Bureau letter and in Milwaukee communications on which it was based.

Enclosed herewith is the original and three copies of a letterhead memorandum reflecting the background on ANGELO PROVINZANO.

Former MI 618-PC, who was the source of the information appearing in referenced letter, is no longer in the Milwaukee area and was not available for interview.

An Anti-Racketeering Case is being opened in the Milwaukee Office on PROVINZANO for the purposes of completing the background after which he may be considered in connection with the Top Echelon Informant Program.

Informants: MI T-1, former MI 618-PC who supplied information to SA JOHN H. GASSAWAY on 1-15-58; MI T-2, is MI 607-C, to SA JAMES E. MC ARDLE in 1958 and 6-12-59; MI T-3 is MI 602-C-TE to SA JOHN H. GASSAWAY on 6-5-59, 4-27-59 and 9-16-59 and MI T-4, JOE BECK, PCI, pinball machine operator in Milwaukee, who supplied information to SA RICHARD C. THOMPSON and SA ALEXANDER P. LE GRAND on 9-27-63.

BECK advised that PROVINZANO had observed Chief of Police POLCYN, Milwaukee Police Department, eating with him six years ago. Immediately thereafter, contacted him to intercede with POLCYN on behalf of TONY MACHI.

He stated two years ago, he had hired a girl who was formerly employed by PROVINZANO as a cashier at

Snack's Restaurant. The girl had worked in a downtown restaurant in Milwaukee owned by BECK and was employed without knowledge of the fact that she was working at this time at Snack's. PROVINZANO telephoned BECK, gave him one half hour to fire the girl, or said he better watch himself. BECK refused to fire the girl, but the incident illustrated to him the hoodlum attitude on the part of PROVINZANO.
