On 12/23/64, JOHN ROSELLI checked into the Desert Inn Hotel in Las Vegas, Nevada. His reservation was made by RUBY KOLOD, part owner of the hotel and ROSSELLI's expected length of stay was four days.

The Las Vegas Office also advised that on 12/25/64 ROSSELLI was called at the Desert Inn Hotel by JOE BREEN and by a GEORGE PALLAY, Room 249, Sands Hotel, Las Vegas. BREEN is a close friend and former business associate of ROSSELLI and is presently employed in a bank in Las Vegas. In the first part of January, ANTHONY ROGEL, PCI, Los Angeles, furnished information that when he was in Las Vegas just before Christmas he talked to GEORGE PALLAY. PALLAY told him that he had come over to Las Vegas with ROSSELLI and has known ROSSELLI for many years. PALLAY also told ROGEL that he had made a trip to Europe to pick up some paintings for ROSSELLI. PALLAY said that ROSSELLI was interested in real estate and that he, PALLAY, would arrange to introduce ROSSELLI to ROGEL in Los Angeles where ROGEL is a real estate salesman. According to ROGEL, PALLAY resides at the Beverly Rodeo Hotel, Beverly Hills, California, when in the Los Angeles area and is reportedly a jewelry salesman. The Los Angeles files reflect that a GEORGE PALLAY (not presently known to be identical with the PALLAY who knows ROSSELLI) was indicted in Cleveland, Ohio, in 1963, in connection with fraudulent stock transactions.
