LA 4268-C advised that on Monday, 12/2/63, ROSSELLI arrived at the Friar's Club, Beverly Hills, California, at about 5:00 PM. He walked into the third floor room with IRVING LEFF, part owner of the Hotel Lost Frontier Corporation, but source does not know if LEFF and ROSSELLI arrived at the club together.

ROSSELLI received a telephone call from an unknown person who apparently told ROSSELLI about someone who had been in an accident as ROSSELLI told this person to send some flowers for ROSSELLI.

HERMAN SPITZEL was also at the Friar's Club and asked ROSSELLI to make a telephone call and "straighten out" some unknown matter.

LA 4268-C stated that ROSSELLI was partly intoxicated when he arrived at the Friar's Club and continued to drink upon his arrival and was in a jovial mood.

The same informant said that ROSSELLI was at the Friar's Club on Thursday, 12/5/63. When source arrived at about 3:15 PM ROSSELLI was having a conference with MORRIE SUESS, a motion picture producer and director. ROSSELLI was still at the club at about 4:15 PM when source left.

Neighborhood source advised ROSSELLI stayed at his Los Angeles apartment on Thursday night for the first time during the current week. On the morning of 12/6/63 he was observed leaving his apartment house in his 1963 Ford Thunderbird and proceed towards Beverly Hills, California.

JOCH WALTERS, PCI, advised on 12/6/63 that JUDITH CAMPBELL, friend of ROSSELLI and of SAM GIANCANA of Chicago, returned to the Beverly Cress Hotel on 12/3/63 and that VICKIE LOCKWOOD, a girl friend of ROSSELLI, stayed at the Beverly Crest Hotel the nights of 12/3 and 4/63. PCI said he observed ROSSELLI at the Hotel on 12/5/63 but he has no information that ROSSELLI visited either of the above women.
