	On 2/11/64 JOHN C. HAGERMAN, Security Manager, Litton Systems, advised that the two men who were driving ROSSELLI's car on 2/4/64 in Los Angeles, and who were accompanied by two Litton Systems employees, are STANLEY PARKER and JACK ZUCKERMAN. HAGERMAN said PARKER owns a company in New York City which manufactures electric light bulbs. ZUCKERMAN is a Vice President, B.M. Company - Electrical Division, Rock Island, Ill., which firm manufactures electrical fixtures. PARKER and ZUCKERMAN were contacting Litton Systems, endeavoring to sell their products for use in a new Litton Systems facility in Des Plaines, Illinois. PARKER told the Litton Systems employee, RICHARD BARGER, that the car (ROSSELLI's) was loaned to him by a close friend.						
	Information has been previously obtained in this investigation from BETSY DUNCAN, PCI, that PARKER was a good friend of hers and was acquainted with ROSSELLI but was not known to be a close friend. DUNCAN is a former girl friend of ROSSELLI.
